

## **Eric C. Shen, P.E., PTP, CPE**

Director of Capital Projects/Chief Engineer  
San Gabriel Valley Council of Governments

Mr. Eric Shen is Director of Capital Projects/Chief Engineer for the San Gabriel Valley of Governments (SGVCOG) and is responsible for planning and implementing a wide spectrum of capital projects throughout the San Gabriel Valley.

Eric administers five on-going freight rail-highway grade separations and two at-grade safety improvements under the Alameda Corridor-East (ACE) Project, with nearly \$1-billion in total project costs. In partnership with LA Metro and Caltrans, Eric oversees the construction of the State Route 57/60 Confluence Chokepoint Relief Project, a \$420 million improvement to the second-highest truck accident location in Southern California and the 7th-most congested truck chokepoint in the US. Eric is also the Principal-in-Charge for the San Gabriel Valley Transit Feasibility and the Vehicle-Miles-Travel (VMT) Regional Mitigation Fee studies.

Eric is a registered Professional Engineer in Alabama and California (Civil), a Professional Transportation Planner (PTP), and a Certified Port Executive (CPE). Appointed by USC as Adjunct Associate Professor of Civil and Environmental Engineering Practice, Eric teaches courses in the Viterbi School of Engineering and the Sol Price School of Public Policy. He also serves as the USC Institute of Transportation Engineers (ITE) Faculty Advisor. Eric received a BSCE with honors and a MSCE from University of California, Irvine.
